EXHIBIT A

Sec. 5-63. Operation and maintenance of keeping fowl.

(a) Fowl as described in Section 5-62 shall be kept at least six feet distance from all property lines and in a fenced enclosure, coop or cage that is at all times maintained in a clean and sanitary manner that mitigates flies and disease. The number of fowl and distances from all neighboring residences shall be as follows:

(1) Three or less fowl
(2) Four to six fowl
(3) Seven to 12 fowl
25 feet from neighboring residences
50 feet from neighboring residences
100 feet from neighboring residences

- (b) No person shall keep or harbor any roosters at a private residence, unless it is zoned for a specific use, other than residential, such as agricultural.
- (c) There shall be no outdoor slaughtering of fowl.
- (d) All fowl shall be kept in such manner as to prevent any public nuisance or health hazard.
- (e) Every structure or other yard arrangement shall be kept so that no offensive, disagreeable or obnoxious smell or odor shall arise therefrom to the injury, annoyance or inconvenience to any nearby residents.
- (f) Waste shall be handled in accordance with Section 5-66.
- (g) Fowl shall be primarily housed in a coop or secure enclosure, not including a general fenced yard. Occasional supervised, free roaming within a fenced area may be permitted, provided it does not create an offensive, disagreeable or noxious smell or odor to the injury, annoyance or inconvenience to any nearby residents and shall be limited to a maximum of five hours per day.
- (h) All structures wherein small animals or fowl are kept shall be maintained in a clean and sanitary condition at all times, with adequate ventilation, devoid of refuse and vermin and free from all offensive odors. The interior walls, ceiling, floors, partitions and appurtenances of all such structures shall be impervious. The enclosed area of all such structures shall be constructed in such a way as to be dry at all times on the inside.
- (i) The Animal Services Manager or his/her designee, may at any reasonable time inspect any structure or premises and issue any order as it may be necessary to carry out the provisions of this section
- (j) Cages and pens for all small animals and fowl shall allow for rest, exercise, and flight that is suitable for the species and shall provide a barrier for predators. Exceptions include veterinary hospitals, grooming shops, and pet shops.

Sec. 5-66. Maintenance of stables, pens, other enclosures; waste removal.

- (a)It shall be the responsibility of every owner, occupant or person in charge of any barn, stable, stall, **corral**, pen or enclosure in which any horse, mule, cattle, swine, **fowl** or any other livestock is kept or any place where manure or liquid discharge of any such animal collects or accumulates to cause such manure or liquid discharge to be removed. Such manure or liquid discharge shall be removed to some proper place outside the limits of the city, or deposited for disposal in an airtight container, to prevent the attraction of insects. Any manure deposited in an airtight container for disposal shall be removed from the city at least once weekly. Any barn, stable, stall, **corral**, pen or enclosure and the drainage yards and appurtenances, shall at all times be kept or cause to be kept in a clean condition. Any manure **present** allowed on any premises within the city for more than 24 hours, including cleanings from any barn, stable, **stall**, corral, pen, **or enclosure or any** truck, coop, wagon or railroad car used for the stabling, penning or transportation of animals or fowl is declared to be a nuisance and, in addition to the penalties provided in Section 1-14 of this Code, subject to abatement by the health officer as provided by law.
- (b) It shall be the responsibility of every owner, occupant or person in charge of any pen, run, cage or yard located within the city, wherein any dog, cat or other animal kept as a pet is maintained, to remove any manure or liquid discharge within 48 hours. Such manure or liquid discharge shall be removed to some proper place outside the limits of the city or deposited for disposal in an airtight container, to prevent the attraction of insects. Any manure deposited in an airtight container for disposal shall be removed from the city at least once weekly. Any manure <u>present allowed</u> on any premises in violation of this subsection is hereby declared to be a nuisance and in addition to penalties provided in Section 1-14 of this Code, subject to abatement by the health officer as provided by law.
